Since only a limited number of parking spaces are available, we would be grateful if you could restrict the number of spaces you order. Visitor car parks are located in the vicinity of the exhibition (EUR 3.- per day/space).

Use of parking space is only valid for the duration of the event. Parking permits must be clearly visible on the vehicles.

Please collect your parking tickets at the exhibition administration at the start of the exhibition by 10.00 a.m. against cash or credit card payment (price includes V.A.T.). Tickets which have not been collected will be given to others.

To use the parking space, please pay attention to the technical guidelines, in particular:

**Roof Avalanche**

In the case of roof avalanche danger the inner courtyard will be closed to traffic. There is no entitlement for an alternative parking space in the immediate vicinity. Also no reimbursements.

**Traffic Resolutions**

To ensure that traffic flows smoothly during the construction and dismantling periods and during the events itself, the rules intended to regulate and direct traffic must be strictly observed.

German Road Traffic Regulations - StVO - apply throughout the exhibition grounds and on the parking areas belonging to the exhibition grounds. The maximum permitted speed on the exhibition grounds is 10 kph.

Illegally parked vehicles, semi-trailers, containers, receptacles and empty packaging of all kinds will be removed at the expense and risk of the owner. The instructions of the persons appointed by MFN to direct and regulate traffic must be strictly complied with, and any corresponding information must be observed.

During the construction and dismantling periods only delivery vehicles are allowed to enter the exhibition grounds - against a deposit. These vehicles are to be unloaded as soon as possible and to be removed from the exhibition grounds. Cars are to be parked on the allocated parking areas. MFN reserves the right to make alterations.

Further deliveries during the event can be made against a deposit. It is forbidden to stay overnight on the exhibition grounds except on the specifically designated caravan sites at P East 2.
